Our distinct approach provides a substantial financial scholarship PLUS individualized support—one without the other is not enough.

### The Scholarship

We help students obtain the strongest possible financial aid for college, and fill the gap with a substantial four-year scholarship to avoid loans.

This enables scholars to graduate DEBT-FREE, on time, and hit the ground running with their degrees.

Only 16% of students from lowincome backgrounds graduate college nationally, and financial hardship is the number one reason.

#### PERSONAL & ACADEMIC MENTORSHIP


